AKTA CUKAI JUALAN 2018

PERINTAH CUKAI JUALAN (KADAR CUKAI) 2022

PADA menjalankan kuasa yang diberikan oleh subseksyen 10(2) Akta Cukai Jualan 2018 [*Akta 806*], menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Cukai Jualan (Kadar Cukai) 2022**.

(2) Perintah ini mula berkuat kuasa pada 1 Jun 2022.

Kadar cukai jualan

2. (1) Kadar cukai jualan yang hendak dikenakan dan dilevikan hendaklah ditetapkan pada sepuluh peratus ke atas semua barang kecuali—

(a) barang yang termasuk dalam mana-mana perintah pengecualian yang dibuat di bawah seksyen 35 Akta; dan

(b) barang yang diimport pada atau dengan mana-mana orang yang memasuki Malaysia atau dalam bagasi orang itu dan barang itu bukan bagi kegunaan perdagangan, tidak termasuk kenderaan bermotor, minuman keras, spirit, tembakau, rokok, tayar dan tiub.

(2) Walau apa pun subperenggan 2(1), cukai jualan yang hendak dikenakan dan dilevikan ke atas barang yang terdapat—

(a) dalam Jadual Pertama hendaklah ditetapkan pada kadar lima peratus; dan

(b) dalam Jadual Kedua hendaklah ditetapkan pada kadar yang dinyatakan dalam ruang (4) Jadual Kedua.

Pembatalan

3. Perintah Cukai Jualan (Kadar Cukai) 2018 [*P.U. (A) 221/2018*] dibatalkan.

SALES TAX ACT 2018

SALES TAX (RATES OF TAX) ORDER 2022

IN exercise of the powers conferred by subsection 10(2) of the Sales Tax Act 2018 [*Act 806*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Sales Tax (Rates of Tax) Order 2022**.
- (2) This Order comes into operation on 1 June 2022.

Rate of sales tax

2. (1) The rate of sales tax to be charged and levied shall be fixed at ten per cent on all goods except—

(a) goods which are included in any exemption order made under section 35 of the Act; and

(b) goods imported on or with any person entering Malaysia or in the baggage of such person and the goods are not for commercial use, excluding motor vehicles, alcoholic beverages, spirits, tobacco, cigarettes, tyres and tube.

- (2) Notwithstanding subparagraph 2(1), the sales tax to be charged and levied on the goods appearing—

(a) in the First Schedule shall be fixed at the rate of five per cent; and

(b) in the Second Schedule shall be fixed at the rate specified in column (4) of the Second Schedule.

Revocation

3. The Sales Tax (Rates of Tax) Order 2018 [*P.U. (A) 221/2018*] is revoked.
