To support the growth of the digital economy, the Malaysian Government intends to implement e-Invoicing in stages in an effort to enhance the efficiency and betterment of the country's tax administration management. The implementation of e-Invoicing is to improve the quality of services and reduce compliance costs to taxpayers, while increasing the efficiency of business operations, as was announced by the Ministry of Finance.

E-Invoice is affecting every one be it businesses or consumers. Thus, all Malaysia residents including visitors to Malaysia will need to understand Malaysia's E-invoice. The following persons should be familiar about Malaysia's E-Invoice as they are directly involved in the E-invoicing process:

Although the first stage of implementation begins in Aug 2024 and is mandatory for business with a sales threshold of RM100m per year, the IRB welcomes organisations who are ready to undertake the programme to volunteer themselves for the pilot project.

E-Invoicing will become mandatory for all taxpayers regardless of sales threshold from July 2025. We should get ourselves ready and to gain an understanding and preparation of Malaysian e-invoicing, identify the impacts and operations.
